



## 2017 HATCH CHILE FESTIVAL VENDOR APPLICATION

*Welcome!*

In an effort to make the 2017 Hatch Chile Festival even greater for the attendees and more profitable for the vendors, we have made some changes to the Vendor Application. Please note the following changes:

- Fees have changed
  - [ All vendors will need to turn in a \$100 deposit for cleanup. If you leave a mess we will keep the deposit- if you clean it up you will gain your deposit back.
- Late arrival may subject you to location changes and late fees
- Vendors should to be set up and open for business before 10:30 AM on Saturday Sept 2nd, 2017
- Absolutely no vehicles of any kind will be allowed inside the grounds after 11:00 AM on Sept 2<sup>nd</sup> & 3<sup>rd</sup>, 2017 either for parking or transporting supplies
- You may be assigned a different location than you have had in prior years.

Types of vendor booths and spaces are as follows: FOOD AND BEVERAGE BOOTH – Must pass propane inspection and local fire department inspection and are required to have a fire extinguisher in the booth at all times.

**Food vendors must obtain and display a permit from the New Mexico Environment Department: 505 476-9102. ! Please Note:**

**Food and beverage vendors cannot sell Coca Cola, Pepsi products, or bottled water at the Festival.**

PRODUCT BOOTH - Sales of services and manufactured goods. No guns, knives or other weapons will be allowed.

GAME BOOTHS/RIDES/SLIDES SPECIALTY ATTRACTIONS CRAFT BOOTHS -Includes hand crafted jewelry, arts, crafts, or other HAND MADE items. 90% of items sold must be hand crafted or home made to qualify for this booth.

CHILE ROASTER - **If also selling merchandise or food you will be classified as a Product Booth**  
DISPLAY/INFORMATION/NON-PROFIT Booth POLITICAL BOOTH – Political materials may only be distributed from a booth. Anyone distributing political materials outside their booth will be asked to leave the Festival grounds.
